Additionally, Samuelson has written over 100 professional [articles](#) in his field, contributed to the *Syracuse Law Review*, and is editor of the prestigious New York State Bar Association's *Family Law Review* and the *Annual Survey of Matrimonial Law* for the American Academy of Matrimonial Law, New York Chapter.
