Barberi, crashed into a pier. Bisignano oversaw the litigation in which the city of New York has paid over \$65 million in compensation to date.

This year, Bisignano completed cases that ended in recoveries of \$3.25 million, \$1.3 million and \$1.1 million in the states of New York, New Jersey and Delaware.

Mr. Bisignano's professional memberships include the Million Dollar Advocates Forum, the American Association for Justice, and the New York State Bar, New Jersey Bar, Maritime Lawyers, Staten Island Trial Lawyers and Richmond County Bar associations. He serves on the board of directors for the New York State Trial Lawyers Association and Richmond County Bar Association where he is also a member of the Judiciary Committee and serves as the Law Day chairperson.

Mr. Bisignano serves on the board of directors for the New York State Trial Lawyers Association, where he is the law day chairperson and a former member of the Grievance Committee.

Bisignano has appeared as a legal commentator on various networks and television shows, including *The Today Show*, *The Geraldo Rivera Show* and *Channel 1 News*. He has also been featured in articles appearing in *The New York Times*, *New York Daily News*, *New York Post*, *Staten Island Advance* and other national publications.
