## **Preston Henrichson named to *Super Lawyers* two consecutive years**

Henrichson has served as Chair on the Texas Commission on Lawyer Discipline and State Bar of Texas, as director of the State Bar of Texas, president of the Rio Grande Valley Trial Lawyers Association and is director emeritus of the Texas Trial Lawyers Association.

A graduate of University of Houston Law Center, Henrichson has practiced law since 1969, and formed his own firm in 1973.
