Von Ellen received her B.A. at the State University of New York, University at Albany and her Juris Doctorate at Union University, Albany Law School.

Additionally, Von Ellen is a current Member of the New Jersey State Bar Association Family Law Section Executive Committee, a Member of the Matrimonial Committee of the Middlesex County Bar Association, the Middlesex County Assignment Judge's Family Lawyers' Committee and the Union County Bar Association Family Lawyers Committee. She is a member of the Union County, Middlesex County, State of New Jersey and American Bar Associations. She has also lectured extensively on various Family Law topics, both on the county level and statewide.
