Steven R. Polidori named to *Super Lawyers* for fifth Consecutive Year

A former Arapahoe County deputy district attorney, Polidori's professional memberships include the American Board of Trial Advocates, American Academy of Trial Counsel and the Colorado Trial Lawyers, Arapahoe County Bar, Colorado Bar and the Italian-American Bar Associations.
